### Conservative Dark Money Donor Groups Have Given A Combined \$89,705,670 To Organizations Pushing The Independent State Legislature Theory At The Supreme Court

**Summary:** The independent state legislature theory is a <u>fringe legal theory</u> that posits that the state legislative body has the sole authority to regulate federal elections. The theory has gained steam among conservatives in recent years and <u>threatens to wipe out most checks and</u> <u>balances</u> when it comes to federal elections. In September 2022, numerous right-wing groups filed Supreme Court amicus briefs supporting the independent state legislature theory in *Moore v. Harper* - a case which will decide whether "<u>the state legislative body</u>, independent of any constraints by state courts or other laws, have sole authority to regulate federal elections." This case, and the prospect of the right-wing Supreme Court validating the independent state legislature theory, is seen by commentators as a <u>path to election subversion</u>.

Five groups who have filed *Moore v. Harper* Amicus Briefs in support of the independent state legislature theory, **Honest Elections Project**, **American Legislative Exchange Council**, **Public Interest Legal Foundation**, **Claremont Institute**, and **America's Future Inc**., have received nearly \$90 million combined from right-wing donor groups soon to be featured on MonitoringInfluence.org since 2016. These donor groups include:
